The arrest warrant may be served anywhere with the jurisdiction of the United States, and an arrest warrant may be served anywhere outside of the United States where "a federal statue authorizes arrest"(THE RACKETEERED INFLUENCED AND CORRUPT ORGANIZATION ACT via HUMAN RIGHTS VIOLATIONS, TERRORISM, MAIL FRAUD, WIRE FRAUD, VIOLATIONS AND A HOST OF OTHER DOMESTIC AND/OR INTERNATIONAL CRIMES). This means a arrest warrant may be executed in a foreign country under a statue, such as the ones giving the Coast Guard and the Military Extraterritorial Jurisdiction Act of 2000, permitting arrest of certain military and Defense personnel oversea, and also foreign official via Racketeering Conspiracy(extraterritorial Jurisdiction) violations of International law(crimes against humanity etc.)violations of the Rome Statute, and for their illegal acts against the two witnesses(Sharon and James Bridgewater)a summons to an organization under rule 4(c)(3)(d) may also be served at a place not within a judicial district of the United States.

### **EXECUTION OF ARREST WARRANTS MEANS ARREST OF PERSON NAMED IN WARRANT**

An arrest warrant is executed by the arrest of the Defendant named in warrant. An arrest warrant is executed by the arrest of the Defendant named or described in the warrant. Then if the defendant requests, the auothrized person must "show the original or a duplicate original warrant to the defendant as soon as possible."

When the arresting officier does not have the warrant in his or her possession at the time of the arrest, the authorized person must "informa the defendant of the warrant's existence and of the offense charged. Hovver, all of the obligations that accompany the execution of an arrest warrant do not govern concrt between the authorize person an the defenatn at tines other than the time of arrest. For example, in pre-arrest contacts, the authorized person has no obligatio to show the defendant anything, or explaint the potential charges on which the defendant may be arrest at some time in the future.

## **NO TIME LIMIT ON EXECUTION OF ARREST WARRANT**

Delays in execution of an arrest warrant do not affects its validity. Once the Defendant is arrested he or she must be brought to "THE 50 STATES EX REL SHARON BRIDGEWATER PRIVATE ATTORNEY GENERAL AND/OR RELATOR COURT ROOM" VIA Virtual hearings are court hearings that take place through phone or video conferences, instead of in-person hearings in the courthouse because of COVID-19 has made in-person hearings unsafe or challenging in the 50 states, so courts are moving hearings online to continue to process cases.
