FRCP 56(c). Disregard for court. In determining whether a genuine issue of material fact exists, the court must consider the evidence and all reasonable inferences in the light most favorable to the non-moving party.

Relevant undisputed facts, are Eric H. Holder Jr. has committed one or more acts of deliberate disobedience or disregard for the laws, regulation, or deorum of public authority and/or this court and/or the legislative body of congress and has been found in criminal and/or civil contempt of court by congress. Further on more than one occasion Eric Holder has had disobedience or disrespect toward the judicial branch of the government and/or this honorable court and/or have interfered with the order process of this court and the sovereignty of this Judicial court which it has been delegated. It is a criminal offense to obstruct a congressional investigative, and disrupt the orderly process of this court and further Eric Holder Jr. actions constitute a “RICO predicate act as defined in 18 USC section 1961.” Other relevant undisputed facts are that the Intervening Petitioner and/or Plaintiff “a qualified” federal witness and a person who have the standing to sue have filed numerous criminal charges against Eric Holder which permit this court to grant the Committee and Oversight motion for summary judgment
