WHEREAS, in the **PEOPLE OF THE 50 UNITED STATES COMMON LAW COURT** on JAN. 21, 2021 the Court entered this judgment in the above entitled cause directing among other things that you and each of you be enjoined and restrained as prayed for in the affidavit filed in said cause against you.

NOW THIS IS TO COMMAND That you, your agents, employees, associates, servant and those in active concert with China, Russia et al foreign official you and each of you do absolutely desist and refrain from GRANTING CHINA U.S. NATIONAL SOVEREIGNTY, denying or abridging U.S. citizens voting rights, committing one or more AND ENGAGING IN A PATTERN OF RACKETEERING ACTIVITY and/or committing one or more as follows:
