The courts’s jurisdiction under the Special Prosecutor statue may be invoved by the court, by the Sharon Bridgewater ex rel on behalf of the United States et al and/or by a private citizen or goup of citizens. See Baxter, 156, 156 III App. 3d 566; In re Appointment of Special State’s Attorney, 305 III. App. 3d.
