## ARTICLE I:

The Constitution provides that the House of Representatives “shall have the sole Power of Impeachment” and that the President “shall be removed from Office on Impeachment for, and Conviction of, Treason, Bribery, or other high Crimes and Misdemeanors”. Throughout the period from Jan. 1, 1993 and continuing thru to present all of the defendants herein, acting in concert with each other and with others, unlawfully, willfully and knowingly were principals in, accessories to, ordered, abetted, took a consenting part in, and were connected with plans and enterprises involving, Genocide, the commission of War Crimes and Crimes, against both Sharon and/or James S. Bridgewater(U.S. Citizens and/or Humanity).

All of the defendants herein, acting in concert with others for Whose acts the defendants are unlawfully, willfully, and knowingly participated as leaders, organizers, instigators, and accomplices in the formulation ,and execution of the said common design, conspiracy, plans and enterprises to commit, and which- involved the commission of, War Crimes and Crimes against the two witnesses Sharon and/or James S. Bridgewater(and/or U.S.Citizens and/or Humanity). It was a part of the said common design, conspiracy, plans and' enterprises to perform meical experiments upon concentration. The said common design, conspiracy, plans and enterprises embraced the commission of War Crimes and Crimes against Humanity, as

cruelties, tortures, atrocities, and other inhumane acts. knowingly, intentionally, The Nuremberg Code aimed to protect human subjects from enduring the kind of cruelty and exploitation the prisoners endured at concentration camps. The 10 elements of the code are:

1. Voluntary consent is essential
2. The results of any experiment must be for the greater good of society
3. Human experiments should be based on previous animal experimentation
4. Experiments should be conducted by avoiding physical/mental suffering and injury
5. No experiments should be conducted if it is believed to cause death/disability
6. The risks should never exceed the benefits
7. Adequate facilities should be used to protect subjects
8. Experiments should be conducted only by qualified scientists
9. Subjects should be able to end their participation at any time
10. The scientist in charge must be prepared to terminate the experiment when injury, disability, or death is likely to occur


**ARTICLE II: ABUSE OF POWER** The Constitution provides that the House of Representatives “shall have the sole Power of Impeachment” and that the President “shall be removed from Office on Impeachment for, and Conviction of, Treason, Bribery, or other high Crimes and Misdemeanors”.
