ORDER

15 On February 18, 2010, Plaintiff commenced the instant action against Defendants.
16 Dkt. 1. Under Rule 4(m) of the Federal Rules of Civil Procedure, "[i]f a defendant is not
17 served within 120 days after the complaint is filed, the court . . . must dismiss the action
18 without prejudice against that defendant or order that service be made within a specified
19 time." On July 29, 2011, the Court directed Plaintiff to effect service on the Defendants
20 within fourteen (14) days from the date she filed her second amended complaint. Dkt. 111.
21 On August 29, 2011, Plaintiff filed a second amended complaint, but failed to effect service
22 on any Defendant within fourteen (14) days. See Dkt. 119. On February 14, 2012, the
23 Court directed Plaintiff to effect service on Defendants within fourteen (14) days. Id. The
24 Court warned Plaintiff that if she failed to timely serve Defendants, this action will
25 dismissed without further notice. Id. To date, Plaintiff has not served any Defendant.

26 Accordingly,

27 IT IS HEREBY ORDERED THAT:

28 1. This action is DISMISSED without prejudice.
