On February 24, 2025 THE “50 STATES” EX REL SHARON BRIDGEWATER PRIVATE ATTORNEY GENERAL AND/OR QUI TAM RELATOR INTERVENE AND/OR FILED A FIRST AMENDED VERIFIED COMPLAINT FOR FORFEITURE ALLEGING THAT property is subject to forfeiture pursuant to 18 U.S.C. § 981(a)(1)(A), and for violations of one or more 18 U.S.C. §§ 1341 (mail fraud), 1343 (wire fraud), 1344 (bank fraud), 1956 and 1957(a) (money laundering), harboring illegal aliens, etc. Also including real or personal, in the United States, which derived from, or traceable to, proceeds obtained directly or indirectly from one or more offense(s) against a foreign nation, and/or property used to facilitate offenses of trafficking in nuclear, chemical, biological, or radiological weapons technology or material, or the manufacture, importation, sale, or distribution of a controlled substance (as that term is defined for purposes of the Controlled Substances Act), or any other conduct described in section 1956(c)(7)(B);






