On February 24, 2025 THE "50 STATES" EX REL SHARON BRIDGEWATER PRIVATE ATTORNEY GENERAL AND/OR QUI TAM RELATOR INTERVENE AND/OR FILED A FIRST AMENDED VERIFIED COMPLAINT FOR FORFEITURE ALLEGING THAT *One or more* property is subject to forfeiture pursuant to 18 U.S.C. § 981(a)(1)(A), and for violations of one or more 18 U.S.C. §§ 1341 (mail fraud), 1343 (wire fraud), 1344 (bank fraud), 1956 and 1957(a) (money laundering), harboring illegal aliens, etc. Also including real or personal, in the United States, which derived from, or traceable to, proceeds obtained directly or indirectly from one or more offense(s) against a foreign nation, and/or property used to facilitate offenses of trafficking in nuclear, chemical, biological, or radiological weapons technology or material, or the manufacture, importation, sale, or distribution of a controlled substance (as that term is defined for purposes of the Controlled Substances Act), or any other conduct described in section 1956(c)(7)(B);

punishable within the jurisdiction of the foreign nation by death or imprisonment for a term exceeding 1 year.

Pursuant to a warrant for arrest *in rem* issued by this court on February 24th, 2025 all Statutory Class Defendant Representatives was served with copies of the declaratory adjudication and/or declaratory relief and/or verified *SUPPLEMENTAL* consolidated affidavit in intervention and/or complaint for forfeiture and warrant of arrest *in rem* and was served with copies via publication of summons and/or arrest for forfeiture, notice of complaint, and warrant of arrest *remainder*. Notice of said civil forfeiture action was posted on an official government internet site(www.thefinalexodus.org) for a period of 30 consecutive days *from April 8, 2024 thru to present*

The defendants have been adjudicated guilty and sentence to death pursuant to antiterrorism and effective death penalty act of 1996, violations of international law (Genocide, War Crimes, etc.) PROCESS WILL BE ISSUED IN THIS ACTION AND RETURN ACCORDING TO LAW AS SOON AS TIME PERMITS.
