

- Chief legal officer (CLO) - officers in charge of all an organization's legal affairs
- Chief marketing officer (CMO) - Corporate executives responsible for marketing activities in an organization
- Chief operating officer (COO) - COO responsible for the daily operation of a company
- Chief people officer (CPO) - Persons in charge of every aspect of the employee life cycle in an organization

- Chief scientific officer (CSO) - heads of scientific research operations at an organizations or company performing significant scientific research projects
