IT IS FURTHER ADJUDICATED, ORDERED AND DECREED that the further prosecution of any pending actions, suits or legal proceedings of any nature or description whatsoever in any Court wheresoever, against the Class Representative Sharon Bridgewater via the "50 States" ex rel Sharon Bridgewater(and/or James S. IT IS DECLARED, DECREED AND ADJUDICATED THAT ALL STATUTORY CLASS REPRESENTATIVES AND/OR MEMBERS ARE Enjoined and/or Restrained from Criminal Prosecutions of both Sharon Bridgewater and/or James S. Bridgewater (Representatives of "Humanity") and/or Authorized Representatives appointed by Sharon Bridgewater via the "50 States" ex rel Sharon Bridgewater Private Attorney General and/or Relator for one or more

- a. Unconstitutional Statute(s)**
- b. Abuse of Process: to harass or to silence the "50 Sates" ex rel Sharon Bridgewater(and/or James S. Bridgewater)protected speech (one or more like First Amendment rights and/or human rights).**
- c. Federalism Issues: One or more Federal courts, Admiralty and/or Maritime Courts, World Courts, International Criminal Courts) for stopping this state actions that violate federal law (and/or other international law).**
- d. Obstruction of Justice: Conspiracy to engage in a pattern of Racketeering Activity – see dismissal of 50 or more cases**


