It is unlawful for anyone maintain and/or be employed by or associated with any enterprise engaged in, or the activities of which affect, interstate or foreign commerce, to conduct or participate, directly or indirectly, in the conduct of such enterprise's affairs through a pattern of racketeering activity or collection of unlawful debt. 18 U.S.C.A. § 1962(c) (West 1984). The Racketeer Influenced and Corrupt Organization Act (RICO) was passed by Congress with the declared purpose of seeking to eradicate organized crime in the United States. *Russello v. United States*, 464 U.S. 16, 26-27, 104 S. Ct. 296, 302-303, 78 L. Ed. 2d 17 (1983); *United States v. Turkette*, 452 U.S. 576, 589, 101 S. Ct. 2524, 2532, 69 L. Ed. 2d 246 (1981). A violation of Section 1962(c), requires (1) conduct (2) of an enterprise (3) through a pattern (4) of racketeering activity. *Sedima, S.P.R.L. v. Imrex Co.*, 473 U.S. 479, 496, 105 S. Ct. 3275, 3285, 87 L. Ed. 2d 346 (1985).

EXTRATERRITORIAL JURISDICTION

In order to for Sharon Bridgewater via the “50 States” ex rel Sharon Bridgewater Private Attorney General and/or Relator(Prosecutor) to prove beyond a beyond a reasonable doubt that the Statutory Class Representatives one or more Kamala Harris individually and/or in her official capacities and/or Merrick Garland individually and/or in his official capacities and Statutory Class members are guilty of Racketeering and/or RICO Conspiracy Sharon Bridgewater via the “50 States” ex rel Sharon Bridgewater Private Attorney General and/or Relator(Prosecutor) must prove: (1) that an enterprise existed; (2) that the enterprise affected interstate commerce; (3) that Statutory Class Representatives Kamala Harris individually and/or in her official capacity as San Francisco District Attorney(and/or her successive official capacities) and/or Merrick Garland in his official capacity as Chief Justice for U.S. Court of Appeals D.C. Circuit and/or Attorney General for the United States of America(Successors and Predecessors from Jan. 1, 1993 and continuing thru to Merrick Garland term) maintained and/or was associated with or employed by the enterprise; (4) that the defendant engaged in a pattern of racketeering activity; and (5) that the defendant maintain and/or conducted or participated in the conduct of the enterprise through that pattern of racketeering activity through the commission of at least two acts of racketeering activity as set forth in the indictment. *United States v. Phillips*, 664 F. 2d 971, 1011 (5th Cir. Unit B Dec. 1981), *cert. denied*, 457 U.S. 1136, 102 S. Ct. 1265, 73 L. Ed. 2d 1354 (1982).

An "enterprise" is defined as including any individual, partnership, corporation, association, or other legal entity, and any union or group of individuals associated in fact although not a legal entity. 18 U.S.C.A. § 1961(4) (West 1984), and Many courts have noted that Congress mandated a liberal construction of the RICO statute in order to effectuate its remedial purposes by holding that the term "enterprise" has an expansive statutory definition. *United States v. Delano*, 825 F. Supp. 534, 538-39 (W.D.N.Y. 1993), *aff'd in part, rev'd in part*, 55 F. 3d 720 (2d Cir. 1995), cases cited therein.

"Pattern of racketeering activity" requires at least two acts of racketeering activity committed within ten years of each other. 18 U.S.C.A. § 1961(5) . In addition the continuity requirement, the “50 States” ex rel Sharon Bridgewater Private Attorney General and/or Relator(Prosecutor) will show and prove that the racketeering acts committed pose a threat of continued racketeering activity by proving: (1) that the acts are part of a long-term association that exists for criminal purposes(in this case , or (2) that they are a regular way of conducting the defendant's ongoing legitimate business, or (3) that they are a regular way of conducting or participating in an ongoing and legitimate enterprise.

Bridgewater) AND/OR HUMANITY in whole or in part and the conduct took place in the context of a manifest pattern of similar conduct directed against both Sharon and/or James S. Bridgewater or was conduct that could itself effect such destruction of both Sharon and/or James S. Bridgewater in violation of **Article 6 (c) Genocide by deliberately inflicting conditions of life calculated to bring about physical destruction**

Bridgewater (and/or class victims) persons belonging to a particular national, ethnical, racial or religious group and/or Humanity and the conduct took place in the context of a manifest pattern of similar conduct directed against Sharon and James S. Bridgewater (and/or class victims) persons belonging to a particular national, ethnical, racial or religious group and/or Humanity or was conduct that could itself effect such

Bridgewater and/or Humanity a civilian population and the conduct was committed as part of a widespread or systematic attack directed against Sharon and James S. Bridgewater(and/or class victims)persons belonging to a particular national, ethnical, racial or religious group and/or “millions” of people members of “Humanity” a civilian population in violation of Article 7 (1) (d)**crimes against Humanity of Extermination**

Bridgewater(and/or class victims) persons belonging to a particular national, ethnical, racial or religious group

and/or was committed as part of a widespread or systematic attack directed against both Sharon and James S. Bridgewater (and/or class victims) and/or humanity a civilian population, and all knew that the conduct was part of a widespread or systematic attack directed against both Sharon and/or James S. Bridgewater (and/or Humanity) a civilian population in violation of Article 7 (1) (c) Crime against humanity of enslavement.

Claimant re-allege #1 and/or #2, deported or forcibly transferred without grounds permitted under international law, one or more Sharon and James S. Bridgewater (and/or class victims) persons belonging to a particular national, ethnical, racial or religious group and/or millions and/or “Humanity to another State or location, by expulsion or other coercive acts (via one or more physical force, threat of force or coercion, such as that caused by fear of violence, duress, detention, psychological oppression or abuse of power against both Sharon and/or James S. Bridgewater and/or millions by taking advantage of a coercive environment) to another Country, State or location, by expulsion or other coercive acts and both Sharon and/or James S. Bridgewater and/or millions and/or humanity were lawfully present in the area from which they were so deported or transferred from all the perpetrator was aware of the factual circumstances that established the lawfulness of such presence and the conduct was committed as part of a widespread or systematic attack directed against one or more Sharon and James S.

Claimant re-allege #1 and on or about Jan. 1, 1993 and continuing thru to present in furtherance of the conspiracy, imprisoned one or more Sharon and James S. Bridgewater(and/or class victims) persons belonging to a particular national, ethnical, racial or religious group and/or millions and/or “Humanity” a civilian population and/or severely deprived one or more one or more Sharon and James S. Bridgewater(and/or class victims)et al persons belonging to a particular national, ethnical, racial or religious group and/or millions and/or “Humanity” physical liberty. .The gravity of the conduct was such that it was in violation of fundamental rules of international law. All of the above perpetrators was aware of the factual circumstances that established the gravity of the conduct, and was committed as part of a widespread or systematic attack directed against one or more Sharon and James S.
