BASIS FOR FORFEITURE

THE RACKETEERED INFLUENCED AND CORRUPT ORGANIZATION ACT IN PERTINENT PART STATES as follows: Whoever violates any provision of section 1962 of this chapter shall be fined under this title or imprisoned not more than 20 years (or for life if the violation is based on a racketeering activity for which the maximum penalty includes life imprisonment), or both, and shall forfeit to the United States (THE “50 STATES” EX REL SHARON BRIDGEWATER PRIVATE ATTORNEY GENERAL AND/OR RELATOR) ,

(1) any interest the person has acquired or maintained in violation of section 1962;

(2) any **(A)** interest in; **(B)** security of; **(C)** claim against; or **(D)** property or contractual right of any kind affording a source of influence over; any enterprise which the person has established, operated, controlled, conducted, or participated in the conduct of, in violation of section 1962; and **(3)** any property constituting, or derived from, any proceeds which the person obtained, directly or indirectly, from racketeering activity or unlawful debt collection in violation of section 1962. The court ([“this Admiralty and/or Maritime Court”]), in imposing sentence on such person shall order, in addition to any other sentence imposed pursuant to this section, that the person forfeit to the United States all property. **(b)** Property subject to criminal forfeiture includes—**(1)** real property, including things growing on, affixed to, and found in land; and **(2)** tangible and intangible personal property, including rights, privileges, interests, claims, and securities. **(c)** All right, title, and interest in property described in subsection (a) vests in the United States upon the commission of the act giving rise to forfeiture under the Racketeered influenced and corrupt Organization Act. All adjudicated guilty as charged for Racketeering Conspiracy (see concurrent filings) and all tangible and/or tangible property is forfeited to the “50 States” ex rel Sharon Bridgewater Private Attorney General and/or Relator, including but not limited to all rights and/or title(s) to public office.

This case has ripened beyond an abstract question into an actual controversy and that is otherwise within this Admiralty and Maritime jurisdiction to terminate the controversy as follows and this Admiralty and/or Maritime case was tried by “Judge, Jury and Executor” THE “50 STATES” EX REL SHARON BRIDGEWATER PRIVATE ATTORNEY GENERAL AND/OR RELATOR without a jury and the following decision was reached

SHARON BRIDGEWATER VIA THE “50 STATES” EX REL PRIVATE ATTORNEY GENERAL AND/OR RELATOR, ILLEGALLY, UNLAWFULLY USURP THE OFFICE AS THE ATTORNEY GENERAL OF THE U.S.A AND IT IS FURTHER DECLARED THAT SHARON BRIDGEWATER BY AND THROUGH THE "50 STATES" EX REL SHARON BRIDGEWATER IS PROSECUTOR FOR MYSELF, MY SON, THE PEOPLE OF SAN FRANCISCO, CALIFORNIA,THE PEOPLE OF THE 50 STATES AND/OR “INTERNATIONAL**

PROSECUTOR”(AS WELL AS JUDGE, JURY AND/OR EXECUTOR) AND HAVE STANDING TO COLLECT FINES ON BEHALF OF THE GOVERNMENT, PROSECUTE CRIMINALS(DOMESTIC AND INTERNATIONAL)AND/OR ACT IN THE BEST INTEREST OF THE UNITED STATES. IT IS FURTHER SO ORDERED THAT PAM BONDI INDIVIDUALLY AND/OR IN HER OFFICIAL CAPACITY AS ATTORNEY GENERAL(AND THOSE OPERATING UNDER THE DIRECTION OF PAM BONDI (AND/OR PREDECESSORS FROM JAN. 1, 1993 AND CONTINUING THRU TO HER TERM AND/OR HER SUCCESSOR) IS STATUTORY REPRESENTATIVE AND “PROTECTOR” AND/OR “CO-LEADER” OF INTERNATIONAL FOREIGN ALIEN TERRORIST ORGANIZATION-RACKETEERED INFLUENCED AND CORRUPT ORGANIZATION ENTERPRIZE.. IT IS FURTHER, ORDERED, DECREED AND ADJUDICATED U.S. CITIZENSHIP IS RETROACTIVELY REVOKED(FROM JAN 1, 1993 AND CONTINUING THRU TO PRESENT)VIA ARE ALIEN ENEMY FOREIGN TERRORIST, ADJUDICATED GUILTY OF REBELLION, INSURRECTION, ADOCATING TO OVERTHROW THE U.S. GOVERNMENT, TREASON ETC. RULE F)**
- 39. IT IS FURTHER SO ORDERED, ADJUDICATED AND DECREED IF A NAME IS LISTED MORE THAN ONCE AS THE “STATUTORY CLASS REPRESENTATIVE AND/OR STATUTORY MEMBERS”IS DOES NOT PROTECT AGAINST MULTIPLE PUNISHMENTS(IS NOT DOUBLE JEOPARDY PROTECT) FOR THE SAME OFFENSE(BUT IS AN ERROR ON THIS COURT PART – AS THERE ARE THOUSANDS OF STATUTORY CLASS MEMBERS.**

40. That process in due form of law issue against **PAM BONDI INDIVIDUALLY AND/OR IN HER OFFICIAL CAPACITY AS FLORIDA AND/OR ATTORNEY GENERAL OF THE USA AND PREDECESSORS FROM JAN. 1, 1993 AND CONTINUING THRU TO HER TERM AND/OR SUCCESSORS(AND/OR STATUTORY CLASS MEMBERS)** and is cited to appear and answer, under oath, all and singular, the matters aforesaid;
41. **IT IS FURTHER SO ORDERED, ADJUDICATED AND DECREED THAT ANY PERSON HARBORING, CONCEALING ETC. PAM BONDI INDIVIDUALLY AND/OR IN HER OFFICIAL CAPACITY AS ATTORNEY GENERAL FOR THE U.S.A. AND/OR HER PREDECESSORS FROM JAN. 1, 1993 AND** for whose arrest a warrant or process has been issued according to the Sworn Criminal Affidavit in the Admiralty and Maritime Court of Competent Jurisdiction and/or prevent , so to prevent the fugitive's(Statutory Class Representatives and/or Members) discovery and arrest, after having notice or knowledge that a warrant or process has been issued via this Admiralty and/or Maritime Court pursuant to 18 U.S.C. § 1071(which can be found at website: <https://www.justice.gov/archives/jm/criminal-resource-manual-1827-harboring-applicable-statutes>)shall be deemed a Co-Conspirator and equally liable for the death penalty fugitive's apprehension.
