You have legal rights and options that you may exercise. Judge THE “50 STATES” EX REL SHARON BRIDGEWATER PRIVATE ATTORNEY GENERAL AND/OR RELATOR VIA ADMIRALTY AND MARITIME COMMON LAW is overseeing this class action lawsuit. What is this lawsuit about?

This lawsuit is about public officials acting in their individual capacities with foreign officials to commit Terrorist acts on US Citizens and knowingly, intentionally violated US Citizens(and others)US Constitutional Rights and Human rights due to allegedly conducting warrantless searches of residential rental properties and for violations of due process for allegedly failing to provide a proper notice and a meaningful opportunity to be heard prior to the

issuance of civil infractions.
Defendant denies any wrongdoing.
Defendant maintains that its ordinances governing rental properties are Constitutional and that it has not violated Plaintiffs' constitutional rights with enforcement of its ordinances.

3. What is a class action and who is involved?
4.

In a class action lawsuit, one or more people or entities called "Class Representatives" (in this case, Claimant The "50 States" ex rel Sharon Bridgewater Private Attorney General and/or Relator sue on behalf of themselves and other people(victims) who have similar claims and/or injuries. The entity sued (in this case, Pam Bondi individually and/or in her official capacity as Attorney General for the United States of America "Prosecutor" acts or omissions(and Predecessors from Jan.1, 1993 and continuing thru to her term and/or Successor)and Kamala Harris in her official capacity as San Francisco, California District Attorney(Prosecutor) and successive capacities as an employee of the United States Government(and/or her Successor) acts or omissions are called the Statutory Class Representatives for the United States of America. In a class action, the Court resolves the issues for all Class members - except those who choose to exclude themselves.

5. What has happened in the lawsuit?

On September 23, 2024, Claimant intervene in the above mentioned lawsuit by filing a sworn affidavit of

The Court entered an Order certifying this lawsuit as a class action, on September 23, 2024, and subsequently filed a Supplemental Consolidated Criminal Sworn Affidavit adding one or more Pam Bondi, Donald Trump, James Davis Vance as Statutory Class Representatives for the USA, entered a Entered a Default Judgment (and a Supplement Default Judgment on February __, 2025). All Statutory Class Representatives and/or members are not entitled to a Jury Trial per Admiralty and Maritime law.

6. What is the current status of the lawsuit? Currently this court the lawsuit was granted class action status on May 23, 2017. Statutory Representative(s) and Statutory Class members have no rights to a Jury Trial pursuant to Admiralty and Maritime law.
7. What are the Class Victim Representatives asking for? The Class Representatives Victim Representative is not asking for anything, and only “taking” via Admiralty and Maritime Claim & RICO forfeiture what rightfully belongs to the U.S.A. and/or Class Victims and to compensate Class

Members Victims for damages that were knowingly, willingly, intentionally caused by all Statutory Class Representative and/or Members heinous criminal conduct against US Citizens(and others).
